## **Meeting Updates:**

• Fred and Bonny attended the Thrive in 05 meeting on March 25<sup>th</sup>.

The main focus was the Tucson House, a park area, garden, and a walking path.

- On March 27<sup>th</sup> a Crime Enforcement meeting at Nash Elementary focused on a project for landscaping and design. The Pascua Yaqui Community Center will try to host events to get the community of come together.
- There will be a Miracle Mile water feasibility study in June. Minimum contamination level is low. TCE not detected above AWOS for several years.

#### **New Business:**

- Fred and Bonny's neighborhood is doing another cleanup this weekend (April 6<sup>th</sup>). Ward III is supplying rolloffs, The Academy of Math and Science will be painting a mural on their wall.
- Arcadia Publishing sent a royalty statement indicating that from
